Opening Remarks: Joe Schmidt welcomed everyone to the meeting, and announced that PAC will take a group photograph for the Parish Directory at next month's meeting.

Reports:

Social Action Commission (Louise Carter):

- o Discussed the Archdiocese Distinguished Speaker program.
- Discussed the Fair Trade sale program.
- Discussed the Commission's plan to recruit new members and their involvement in the annual Commission recruitment process.

• Faith Formation Commission (Joe Schmidt):

- Discussed the Commission's plan to recruit new members and their involvement in the annual Commission recruitment process.

Project List (Deacon Chris Rauch)

- Deacon Chris provided a status of acquiring a contractor to make roof repairs previously approved by PAC. Currently he has acquired bids from four contractors.
- The repair of a large pothole in the apron on the south side of the building (previously approved by PAC) has been put on hold until warmer weather arrives in the spring.
- The church office space study is back from the architect and will be corrected prior to sending to the city of Centerville for approval.
- Deacon Chris has initiated a project to paint areas around the Church utilizing free labor from Kohl's "Outreach" program.
- An interior designer is scheduled to visit on October 25 to begin developing a plan to beautify the church space.
- o Interviews to select a new Music Director should be completed by the end of October.
