Opening Remarks: Joe Schmidt welcomed everyone to the meeting.

Reports:

- Social Action Commission (Andy Devito):
 - Discussed various upcoming events for the month of May.
 - Reviewed Committee feedback from the recent ministry fair.
 - Discussed parish involvement with immigration reform.
- Faith Formation Commission (Lauren Rau): Discussed preparations for their upcoming Ministry Fair, scheduled May 20-21.
